



Corrigendum to Commission Notice – Guidelines for the implementation of certain labelling provisions of Regulation (EU) 2019/787 of the European Parliament and of the Council of 17 April 2019 on the definition, description, presentation and labelling of spirit drinks, the use of the names of spirit drinks in the presentation and labelling of other foodstuffs, the protection of geographical indications for spirit drinks, the use of ethyl alcohol and distillates of agricultural origin in alcoholic beverages, and repealing Regulation (EC) No 110/2008

7. On page 32 , in the box #32:

(a) for: '1) **Spirit drink**

Made of Rum and Brandy,

read: '1) **Spirit drink**

Made of Rum and Brandy';

(b) for: '2) **Rum based**

Spirit Drink

With spices,

read: '2) **Rum based**

Spirit Drink

With spices';

(c) for: '3) **Spirit drink**
Obtained from Rum (15 % vol.),'

read: '3) **Spirit drink**
Obtained from Rum (15 % vol.)'.

8. On page 33 , in the box #33, points 2 and 3:

for: '2) **Single Malt Whisky***
Matured in Cognac barrel / Rum Cask Finish
3) **Spirit Drink**
Mixture of Gin 95 % & Rum 5 %
Matured in Rum Cask,'

read: '2) **Single Malt Whisky***
Matured in Cognac barrel / Rum Cask Finish
3) **Spirit Drink**
Mixture of Gin 95 % & Rum 5 %
Matured in Rum Cask.'

9. On page 34 , in the box #34:
